CIRCULAR

It is to inform all concerned that RIICO has allotted land measuring 32383.05 sqm at I/A Shahdod to Kahrani Green Treaters Association, an SPV, for setting up CETP for beneficiary industries located in I/A Kahrani, Chopanki and Pathredi vide allotment letter dated 21.10.2021 at a token price of Rs. 1/- . Kahrani Green Treaters Association is an SPV registered under the Companies Act, 2013, by Registrar of Companies on dated 14.10.2019. As per MOA, the object of the company is to establish, develop, run and CETP's, STP's, UF & RO plants etc. for industrial as well as domestic uses.

As per the guidelines issued by RSPCB, the beneficiary industries has to form SPV for operation and maintenance of CETP. Further to comply various directions issued by Hon'ble NGT, New Delhi it has been utmost necessary to setup CETP at Kahrani for abatement of water pollution.

Further it is to inform all concerned that as per the terms and conditions of allotment letter/ transfer permission letter/lease deed, all the beneficiary industries are under obligation to become member of the SPV for the purpose. The terms and conditions are as under:-

- 1.The Lessee shall mandatorily become a member of SPV (Special Purpose Vehicle) created under the Companies Act 1956 or 2013, as the case may be for setting up and operation & maintenance and further up-gradation of the CETP Infrastructure and Solid Waste (Hazardous and Non-Hazardous) Disposal System (SWDS) or any other measures required for abating any type of pollution
- 2.That all the Capital & Revenue expenses relating to acquisition of land for CETP, construction and operation and maintenance of CETP Infrastructure & SWDS shall be borne by the Lessee being member of the SPV in the proportion as decided by the Board of Directors of such SPV or any other competent authority in this regard.
- 3.The Lessee shall abide by all the terms and conditions imposed by the concerned authorities in Environmental Clearance Consent to Establish/ Consent to Operate, CGWA approval obtained by RIICO for development of industrial area concerned to the extent of these applicability on the Lessee' unit.

It is further informed to all concerned that as per terms and conditions of CTE/CTO issued by RSPCB, all the units has to apply & obtain membership of local trust, if any, constituted for operation & maintenance of common effluent treatment plant and submit copy of membership document to their office within one month from the date of issuance of consent letter.

Therefore all the beneficiary industries and effluent discharging industries located in I/A Kahrani, Chopanki and Pathredi are requested to obtain membership from Kahrani Green Treaters Association within 30 days.
